## AGREEMENT OF RELEASE FOR MEMBERSHIP

6. Mutual covenants not to sue me from my fellow members, in the event any act of mine causes bodily injury or property damage to them during an actual sanctioned periods.
7. Limited liability Coverage as provided in the insurance policies.

(B) All of the above mentioned **BENEFITS** do not necessarily apply to Club, Patron, or Associate. Nevertheless, this Release must be signed by all members. **IN CONSIDERATION** of being granted the above Benefits of membership in Super Boat International Productions, Inc.® I, **THE UNDERSIGNED**, for myself, my personal representatives, heirs, next of kin, successors and assigns, **DO**:

1. **HEREBY AGREE TO ASSUME ALL RESPONSIBILITY AND LIABILITY FOR ALL ACTS OR ACTIVITIES** of myself, my drivers, assistants and crew for any and all damages or injury that may be caused by any or all of us or by our boat, motor, properties or possessions in any way growing out of or resulting from the operation of my **SBIP** registered boat racing equipment and/or as a result of our participating in an **SBIP** regatta or time trial during the actual Sanctioned Period.
2. **HEREBY AGREE** to be bound by all of the rules of the SBIP and agree that decisions of its officials and/or interpretation of its rules will be governed exclusively by the administrative review and appeal procedure set forth in such rules.
3. **HEREBY ACKNOWLEDGE AND AGREE** that I have no right, property or interest in any radio or television broadcast, motion pictures, still photographs, tape or sound reproduction taken, made, transmitted, reproduced, or used for any purpose of any SBIP sanctioned event, including practice, qualifications, the race, awards ceremonies or other events associated with the racing event, also including, but not limited to pictures and sound of me alone or with other persons, with or without racing equipment, as well as any and all receipts there from, and any transcription thereof.
4. **IN CONSIDERATION OF THEIR PROMOTIONAL EFFORTS ON BEHALF OF THE SPORT**, I hereby assign all commercial communication and broadcast rights to the Super Boat International Productions Inc.® and do declare it as my lawful agent and representative regarding such rights. **I GRANT SBIP** their legal representatives, and assigns, the right and permission to copyright and/or use, publish, and reuse and republish my voice and/or image (including pictures of my racing equipment and pictures taken at any SBIP sanctioned event for publicity purposes) through audio/video/electronic/DVD footage, photographic pictures, negatives or portraits made of me in which I may be distorted in character or form, representing my own name or a fictitious name by which I am known, through any media and for whatever purpose they choose. I hereby release, discharge and agree to save harmless SBIP, their representatives, assigns, employees, corporation or corporations, acting under their permission, including any firm publishing or distributing the finished product, even though the finished product may be distorted, blurred, altered, or used in composite form, either intentionally or otherwise. I hereby waive any right to approve the finished product or any copy which might be used in conjunction with the finished product.
